### RATES IN U.S. DOLLARS

These fees include a Concert Performance, and a Dress Rehearsal on the evening prior to performance. For a second performance of the same repertoire and in the same venue, add 50% of performance fee.

#### Paul Halley, solo

Paul Halley, Guest Conductor or as featured Guest Artist \$2500 fee

Paul Halley, Solo organ recital – may include piano repertoire \$3000 fee

#### Paul Halley and Instrumental Ensemble Repertoire

'Triptych' (Trio of piano, pipe organ, harpsichord) \$4500 total  
Paul Halley and two associate keyboardists

'Angel On A Stone Wall' (Instrumental – piano, drums, percussion, bass, guitar, organ) \$6250 total  
Paul Halley and five additional players

#### Paul Halley and themed choral repertoire, performed with resident choir

'Sound Over All Waters' or 'Missa Gaia/Earth Mass' \$4000 total

With Paul Halley, keyboards and bandleader, and Nick Halley, drums

*Includes fee for extra rehearsal for Paul and Nick Halley to perform this concert with local players.*

Add The Nick Halley Band for 'Sound Over All Waters' or 'Missa Gaia' show

Additional Instrumentalists: Bass, Percussion, Soprano Saxophone, Guitar \$2250 add'l

#### **Payments**

A deposit of 20% of the total fee is due upon the signing of the contract to secure the date with the Artists.

An additional deposit of 30% of the total fee is due 90 days prior to the concert performance date.

The remaining balance of 50% of the total fee must be received in the Pelagos office no later than the day of the concert performance. All deposits and fees shall be made payable in U.S. Funds to "Pelagos Inc."
